Nomination call letter for Fairmont Chateau Lake Louise bargaining committee.

Dear Sisters and Brothers,

With the upcoming expiry on January 31st, 2022, of the collective agreement between the Local Union and Fairmont Chateau Lake Louise, we will begin the process electing representatives from your workplace to negotiate a new agreement. The Local Union will be holding nomination and elections for the bargaining committee for the 2022 negotiations with Company. The committee will be comprised of **2 rank and file members and the Chief Shop Steward.**

Nominations will be held from **February 7, 2022 till February 15, 2022.** If you are interested in being a part of the bargaining committee for your workplace, please fill out the nomination form and return it to the Local Union on or before **February 15, 2022.** Nominees must accept their nominations by **February 17, 2022** be on the ballot and in the election. Once the nomination and acceptance process has been completed, if necessary, an election will be held.

Included in this mail out you will find a nomination form for representation and a "Top 5" questionnaire that we ask you fill out and return it to the local Union office. The questionnaire will help the bargaining committee craft the new proposals for when we meet with Fairmont Chateau Lake Louise, so we ask each member to fill out the form as soon as possible.

We will hold a meeting to discuss proposals that you would like to see brought to the negotiation table. The date and time will be posted in February 2022 at the work site.
