## Nomination and Elections for Bargaining Committee GFL Fort McMurray

Dear Brothers,

With the upcoming expiry on October 31<sup>st</sup>, 2024, of the collective agreement between the Local Union and GFL, we will begin the process electing representatives from your workplace to negotiate a new agreement. The Local Union will be holding nomination and elections for the bargaining committee for the 2024 negotiations with GFL.

**The committee will be comprised of:**

1-rank and file member from **Fort McMurray** as well as the Local Servicing Representative and National Representative.

Nominations will be held from July 18<sup>th</sup>, till July 31<sup>st</sup>, 2024. If you are interested in being a part of the bargaining committee for your workplace, please fill out the nomination form and return it to the Local Union on or before **July 31<sup>st</sup>, 2024**. Once the nomination process has been completed, if necessary, an election will be called shortly thereafter. All nominees must accept their nomination in writing to the Election Committee via email before **August 2<sup>nd</sup>, 2024** at 5pm mountain time to have their name on the ballot and be in the election.

Included in this mail out you will find a **nomination form for the bargaining committee** and a **“Top 5” questionnaire that we ask you fill out and return it to the local union office**. The questionnaire will help the bargaining committee craft the new proposals for when we meet with Cascade, so we ask each member to fill out the form as soon as possible.

**We will hold a meeting to discuss proposals that you would like to see brought to the negotiation table. Please watch for poster at the work site and on the website [unifor4050.ca](http://unifor4050.ca)**
