With the expiry on October 31st, 2021 of the collective agreement between Unifor Local 4050 and GFL, we will begin the process electing representative from your membership to negotiate a new agreement. The Local Union will be holding nomination and elections for the bargaining committee for the 2022 negotiations with GFL.

The committee will be comprised of:

- 1- rank and file member from **Fort McMurray** as well as the Local Servicing Representative and National Representative.

Nominations will be held from **April 8th, 2022 till April 19th, 2022**. If you are interested in being a part of the bargaining committee for your workplace, please fill out the nomination form and return it to the Local Union. Once the nomination process has been completed, if necessary, an election will be called shortly thereafter, please watch for posters.
