Nominations Open:

Monday June 28, 2021 – Nominations Open.

Nominations Close:

Wednesday July 7, 2021 – and must be received by 5:00pm MST by fax, or email.

Acceptance Deadline for Nominated Position(s):

Friday July 9, 2021 at 5:00 pm MST – The nominee must notify the election committee in writing that they accept the nomination and allow their name stand for a position. Acceptance in writing must be received by the committee by 5:00 pm MST on July 9, 2021. This can be done by email to the committee at election@unifor4050.ca or by fax at 1- (877) 489-8203.

Deadline To Place a BIO For Candidates Running For Election(s):

Friday July 9, 2021 at 5:00 pm MST – Must be received by fax or by email (election@unifor4050.ca) in .pdf format when emailed (other file formats will not be accepted). Bio must be formatted for a single sheet of paper 8.5" X 11" (one side only).

Election Committee in at Local Office to Validate Election(s):

Saturday July 10th and Sunday July 11th, 2021, to validate Candidates running in election; approve BIO's, prepare and mail out election materials. Information sent to all units; in regards to the process and a list of all the candidates running and also lists those that were in by acclimation.

All Voting will be done by a “Mail-Out/Mail-In” Ballot(s).

If you do not receive your election package by July 23rd, 2021, you must contact the election committee by email (election@unifor4050.ca) as the packages will be re mailed by July 24th, 2021.

It shall be the responsibility of each member who wants to vote to make sure they have a ballot and get it back into the Local Office by the Deadline of Friday August 13, 2021

Names of nominees will be listed in alphabetical order on the ballot with in each position.

The following process will be for both Executive Positions (1st Vice President and Trustee); A winner will be declared if the candidate receives fifty percent (50%) plus one (1) of the votes. If no winner is declared, a run-off election will be held. The run-off will be held by the two (2) top candidates who receive the most votes.

***The following process will be for Prairie Council Delegate Positions:
A winner will be declared for the candidate with the most votes cast.***

***The following process will be for Canada Council Delegate Positions:
A winner will be declared for the candidate with the most votes cast.***
