Fairmont Palliser 2023 Negotiations and Nomination for Bargaining Committee.

Dear Sisters and Brothers,

With the upcoming expiry on February 28th, 2023, of the collective agreement between Local 4050 and Fairmont Palliser, we will begin the process electing representatives from your workplace to be on the negotiation committee and negotiate a new agreement. The Local Union will be holding nominations and elections for the bargaining committee for the 2023 negotiations with the Company. The committee will be comprised of 4 rank and file members plus the current chairperson, (one (1) member from banquets, one (1) member from guest services, one (1) member from housekeeping, and one (1) member from outlets).

Nominations will be held from **January 16th, 2023 to January 25th, 2023**. If you are interested in being a part of the bargaining committee for your workplace, please fill out the nomination form and return it to the Local Union via fax or email on or before **January 25th, 2023 at 5:00 pm**. Letter of acceptance and biographies deadline is **January 27th, 2023**. If more than one candidate is nominated in any of the four (4) groups then a “online election” will take place.

Included in this mail out you will find a nomination form for representation and a “Top 5” questionnaire that we ask you fill out and return it to Jay Thompson by email at rep@unifor4050.ca or fax it to the Local Union office (1-780-486-0671). The questionnaire will help the bargaining committee draft the new proposals for when we meet with the Company, so we ask each member to fill out the form as soon as possible.

We will hold a meeting to discuss proposals that you would like to see brought to the negotiation table. The meeting will be held at the Hotel (Date to Be Announced please watch for posters).
