Sheraton Eau Claire 2023 Negotiations & Nominations for Bargaining Committee.

Dear Sisters and Brothers,

With the upcoming expiry on October 20th, 2023, of the collective agreement between Local 4050 and Sheraton Eau Claire, we will begin the process electing representatives from your workplace to be on the negotiation committee and negotiate a new agreement. The Local Union will be holding nominations and elections for the bargaining committee for the 2023 negotiations with the Company. The committee will be comprised of 5 rank and file members, one (1) member from banquets, one (1) member from guest services, one (1) member from housekeeping, and one (1) member from outlets and one (1) member from maintenance.

Nominations will be held from **March 8th, 2023 to March 23rd, 2023**. If you are interested in being a part of the bargaining committee for your workplace, please fill out the nomination form and return it to the Local Union via fax or email on or before **March 23rd 2023 at 5:00 pm**. Letter of acceptance and biographies deadline is **March 25th, 2023 at 5:00 pm**. If more than one candidate is nominated in any of the five (5) groups then a “online election” will take place.

Included in this mail out you will find a nomination form for representation and a “Top 5” questionnaire that we ask you fill out and return it to Jay Thompson by email at rep@unifor4050.ca or fax it to the Local Union office (1-877-489-8203). The questionnaire will help the bargaining committee draft the new proposals for when we meet with the Company, so we ask each member to fill out the form as soon as possible.

We will be hold meetings to discuss proposals that you would like to see brought to the negotiation table. The meeting will be held at the Hotel on **March 14, 2023 - 7:00 am till 4:30 pm in the Foxglove room and April 22, 2023 - 7:00 am till 4:30 pm in the Foxglove room.**
